HIGHLIGHTS

Community Events, New Relationships, and Renovations

We've had a busy year at Yahara House, full of new relationships and new events. We both presented and hosted an informational table at our State NAMI Conference. Yahara House championed a table at the annual NAMI Dane County Banquet, where a current member won an award for her mental health advocacy. The event also featured the art of one of our members, who sadly passed in 2022. Yahara House also hosted a table and facilitated a community craft at the Journey Mental Health 75th Anniversary Wellness Event.

Alongside the four other accredited Wisconsin Clubhouses, we restarted the Wisconsin Clubhouse Coalition. Together we encouraged local and state legislators to create Clubhouse-specific funding across the state.

In October we partnered with the Crystal Corner Bar for a music-based fundraiser, where we raised almost two thousand dollars to bring in members who don't have a funding source.

As part of our work with Clubhouse International, three YH colleagues went to the national training seminar in Salt Lake City. In addition one of our members join the Clubhouse International Faculty.

The Clubhouse also has been hard at work creating a more accessible and attractive environment. We completed a large landscaping and outdoor renovation project.

Yahara House also continued in major annual events and projects. This includes our Day of Giving Thanks and spring Gallery Night, both of which we will be continuing in 2024.

CLUBHOUSE PARTICIPATION

In 2023, 174 members utilized Yahara House and engaged in 19,926 hours of Clubhouse work. This includes 441 virtual Clubhouse hours from those who couldn't physically access the program, and 18,807 hours of work within the building.

EMPLOYMENT & EDUCATION

As a core principal of Clubhouse programming, Yahara House has maintained strong employment supports for members at three different levels: Transitional, Supported, and Independent Employment. Members collectively worked 27,726 hours in 2023, earning a total of \$364,744.

Two local businesses developed Transitional Employment positions with Yahara House: Medical Health Pharmacy and Journey Mental Health Records Department.

Four Yahara House members were enrolled in school. The Clubhouse provided support through organized study groups, encouragement, and tutoring.

FUNDING AND LEGISLATIVE EFFORTS

The Wisconsin Clubhouse Coalition (WCC) successfully educated legislatures on the benefits of Clubhouse programs in Wisconsin. Assembly Bill 251, authored by Representative Paul Tittle, proposed up to \$50,000 in matching grants to Wisconsin Clubhouses for up to five years. Senator Rachael Cabral–Guevera amended the Senate version, SB350, to draw on federal mental health block grant funds. A public hearing was held in the Senate, but not in the Assembly, so the bill needs to be reintroduced. Legislatures, community partners, and Clubhouse colleagues are invested in continuing to find ways to strengthen Clubhouses across the state.
